5514 STUDENT USE OF VEHICLES ON SCHOOL GROUNDS

The safety of students, staff members, school visitors, and others while on school grounds is of significant importance to the Board of Education. A student's use of a vehicle and/or other modes of transportation on school grounds has the potential to present a safety hazard for the student operator and to other students, staff members, school visitors and others while on school grounds.

Students in grades 11 & 12 are permitted to drive their automobile to and from school and park in the area designated for student parking.

The student must register their automobile with the Principal or designee who will provide the student with school rules for driving and parking on school grounds. The school's rules may require a permit that must be affixed on a window or be clearly visible from outside the automobile when the automobile is parked on school grounds.

Parking Rules and Regulations

- 1. All parking permits will be purchased in the Main Office for \$20.00. Students will park in the assigned numbered student parking areas.
- 2. Students are not permitted to use the inter-district connecting road between the High School and the Middle School.
- 3. No student will be permitted to go to his/her automobile during the school day without obtaining permission from main office and signing out on appropriate form.
- 4. Smoking is not permitted in the automobile while it is on school property.
- 5. Speed limit, traffic patterns, and safe driving practices (ex. seat belt usage) will be followed while on school grounds. The speed limit on school property is 10 miles per hour.
- 6. No student will be permitted to transport other students away from school property before the school day ends (unless students are from the same immediate family and have parent permission).
- 7. Parking decals, obtained from the office, must be used.
- 8. All vehicles parked on school property are subject to inspection by school

officials, law enforcement officials, and drug detection canines. Violations of a criminal nature will be prosecuted to the fullest extent.

- 9. Decals are not transferable. Parking will be revoked if given to another student for use.
- 10. Students who have exceeded their attendance points will have their parking privileges revoked and vehicles will be towed.
- 11. If you have your Provisional New Jersey Driver's License, students are expected to adhere to all New Jersey rules and regulations (ex. number of passengers).
- 12. As per Clearview Regional Board of Education Policy (5530.1), students who purchase a parking permit will be subjected to random drug testing during the course of the school year. Prior to students receiving their permit, students and their parents/guardians, must sign the Student and Parent/Guardian Consent Form. Students will not be issued a permit without this signed form.
- 13. Parking is reserved for Seniors/Juniors who will routinely drive to school. If a spot is not used, it may be reassigned to another student.
- 14. The School District is not responsible for any damage or theft to any car or its contents.
- 15. As a result of N.J. Statute and information sharing with police, your parking privilege may be revoked for motor vehicle violations and complaints obtained off of school grounds. The school resource officer may also revoke parking at any time.

Students are permitted to ride bicycles only to the following schools in the school district:

Students riding bicycles to school must comply with all applicable State and local laws for operating a bicycle. The Principal of each school may develop school rules for the operation of the student's bicycle on school grounds. Students must park and lock their bicycles in an area outside the school building designated by the Principal. A bicycle may not be brought into the school building without the Principal's permission.

Students are permitted to bring on school grounds non-motorized skateboards, scooters, roller skates, or any other non-motorized mode of transportation the student may use to get to and from school. The Principal shall determine if such items may be brought into

the school building during the school day.

Students that bring these items to school must comply with all applicable State and local laws for operation. The Principal of each school may develop school rules for the operation of the student's non-motorized items on school grounds and if such items can be brought into school and where such items shall be stored, in or outside the building, during the school day.

Students are not permitted to bring any motorized bicycle, skateboard, scooter, roller skates, hover-board, or any other motorized mode of transportation on school grounds during the school day.

The Principal of each school building may revoke the privilege of a student's use of any vehicle or mode of transportation permitted by this Policy for the student's failure to follow the provisions of this Policy and any requirements of State or local law or any school rule. The Board of Education assumes no responsibility for the loss, damage, or theft of any vehicle or any mode of transportation permitted on school grounds in accordance with this Policy.
